

Bashas' 2019 Unilever BBQ Grill Sweepstakes

Bashas' Inc., their subsidiaries and affiliated companies (together, the "Company"), will conduct the Sweepstakes substantially as described in these rules, and by participating, each participant agrees' as follows:
