



## 5<sup>th</sup> Annual Donut Flavor Craze Contest

### OFFICIAL RULES

1. NO PURCHASE OR PAYMENT OF ANY KIND NECESSARY TO ENTER OR WIN THIS CONTEST. VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, U.S. TERRITORIES AND POSSESSIONS AND WHERE PROHIBITED OR RESTRICTED BY LAW.

2. HOW TO ENTER: Contest begins on 05/01/20 and ends on 5/17/20 (“Contest Period”). Enter by submitting on the Bashas’ website contest page at [www.bashas.com/flavorcraze](http://www.bashas.com/flavorcraze). All entries must be received by 11:59 p.m. on 5/17/20. Tell us in 100 words or less what your Love of Arizona donut flavor idea is, including the proposed name, key ingredients and why it should win. Limit one entry per person and per household. Neither Bashas’, Inc. (“Bashas’”), nor their respective employees, representatives or agencies, is responsible for lost, late, damaged, delayed, destroyed, misdirected, incomplete, or illegible entries. 3. ELIGIBILITY: Open only to legal U.S. residents of AZ who are 8-17 of age in the Youth Category and 18+ for the Adult Category at time of entry. Employees of Bashas’, Inc., their respective parents, subsidiaries, and other affiliated companies, agents, advertising and promotional agencies, and their immediate families or persons residing in the same household of such employees are not eligible to enter or win.

4. ODDS OF WINNING PRIZE: Sponsor will select ten (10) top finalists (five (5) from youth & five (5) from adult) from all of the submissions on or about May 20<sup>th</sup>. From these top finalists a panel of local celebrities will select two (2) Grand Prize winners (One for the youth category and one from the adult category), two (2) Runner-ups and six (6) honorable mentions (3 from the youth category and 3 from adult category). Odds of winning depend on the number of eligible

entries received. Entrants and prize-winners agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects. Winners will be notified by phone or e-mail. Winners must sign a media release form. In the event of non-compliance with these requirements, the prize will be forfeited and an alternate winner will be selected.

5. PRIZES: Sponsor will award two (2) Grand Prizes winners (One for the youth category and one from the adult category). Adult Category Grand Prize winner will receive \$500 worth of prizes; including a Bashas' Gift Card, family fun activities and baking/cooking gadgets, one (1) dozen donuts per month for 12 consecutive months and their donut will be featured in all Bashas' bakeries for one (1) month (ARV=\$130.60). The remaining six finalist, will have an honorable mention (three for the youth category and three from the adult category) will consist of one (1) \$20 Bashas' Gift Card.
