OFFICIAL SURVEY RULES & REGULATIONS

8th Annual Donut Flavor Craze Contest for Bashas' and Bashas' Dine Market.

2. How to Enter:

1. Sweepstakes will begin on April 10, 2023 at 12:00 a.m. Mountain Standard Time ("MST") and end on May 13, 2023 at 11:59 p.m.

- 2. To be eligible, entries, for both divisions must be received within the sweepstakes time frame and will be based in MST and timestamp of the submission email.
- 3. To enter online, you must enter your name, address, zip code and valid email address or phone number. Limit one internet entry per household and one internet entry per email address per contest period. Internet entries will be deemed made by the authorized account holder of the email address submitted at the time of entry. - 1. Following completion of the entry period, all submission will be reviewed by the Bashas' Public Relations Department and the Bashas' Bakery Department. Finalists will be identified and announced on May 18th.
- 2. The finalist donut creations will be brought to life by the Bashas' bakery department and judged by local celebrities, news/media anchors & hosts, members of the Basha family and Bashas' bakery department.
- 3. All judges will score each donut on a 1 to 10 scale with 10 being the highest single judge points awarded. Points are tallied from all judges for all donut submissions to determine the grand prize winner in each category.
- 4. Finalists will be notified via e-mail or phone on or before the May 18th.
- 5. Grand prize winners will be notified on May 30th.

5. Conditions:

- 1. Payments of all federal, state and local taxes are the sole responsibility of the winner. Winner may be required to sign an IRS Form W-9 or the equivalent.
